All 50 States, the District of Columbia, American Samoa, Guam, the Northern Mariana Islands, Puerto Rico, and the U.S. Virgin Islands have laws and policies that specify procedures for making and responding to reports of suspected child abuse or neglect. Mandated reporters are required by States to make an immediate report when they suspect or know of abusive or neglectful situations. We need to do better

was 12 and my brother was 13 when the firsttime CASA volunteer met with us in our foster home. I remember the smile on her face and a quality about her that put us at ease. We were in a high level of care when we entered the system because we was angry that our sister was not put in the same home....plus we had been living on the streets, in cars, and in shelters. The CASA quickly learned that we weren't going to school because we was missing

clean clothes, meals, and support that would allow us to make school a priority.

My CASA was there when no one else was. She was there when we fought our biggest struggles in foster care. She inspired

us when we felt most uninspired. She motivated us to keep our grades up and stay in school. She also motivated us to dig deep within to overcome our toughest emotions. She gave us a high level of confidence. My brother and I overcame our challenges and achieved

many things. We earn A's and B's and in a much lower level of foster care. My CASA worker helped me to get into activities and take leadership roles. She put forth so much effort to ensure our success and without her immense inspiration and concern, I would not have the motivation or the desire to make a difference in the lives of others.


